Second Party will FIX the G.P.S (As per the specifications laid down by PC-PNDT Authorities, Jaipur, Rajasthan) with unique S.No. other than IMEI No. with USG machine at First party ware house.

First Party will transport the USG machine to the Customer who should have valid PNDT registration and permission to buy new machine from District. Appropriate authority, PCPNDT

The following will be done by Second party engineer:

1. Activation of GPS at customer site
2. Login to the website address and generate the test report/SMSAlert/e-mail alert to ensure the working & current location on GPS website.
3. Will keep the website functional 24x7 for anytime access/tracking and provide report for the same
4. Preparation of installation report of GPS
5. Website address, sufficient user IDS, password and user manual would be provided to concerned SDAA/DAA/SAA.
6. The second party shall maintain and provide necessary services for continuous uninterrupted working of GPS system and shall attend to any complaint within 24-48hrs
7. The Price of the device shall be fixed and remain the same for first 2 years and subsequently cannot be increased by more than 10% per year
8. The second party shall provide monthly and quarterly reports for the proper functioning of the device
9. The second party shall provide user manual/operating instructions for the device
